Glucagon for Injection INDICATIONS AND USAGE

Glucagon for Injection is a gastrointestinal motility inhibitor indicated for use as a diagnostic aid during radiologic examinations to temporarily inhibit movement of the gastrointestinal (GI) tract

Limitations of Use:

Fresenius Kabi Glucagon for Injection is not indicated for the emergency treatment of hypoglycemia

Pheochromocytoma

WARNINGS AND PRECAUTIONS

• <u>Hyperglycemia in patients with diabetes:</u> Monitor blood glucose and treat with insulin if indicated

<u>Increased blood pressure and heart rate in patients with cardiac disease:</u> Monitor patients with known cardiac disease

 <u>Allergic reactions including anaphylactic shock with breathing difficulties,</u> and hypotension, generalized rash: Discontinue and treat as indicated

ADVERSE REACTIONS

Adverse reactions seen with glucagon are transient changes in blood pressure, increase in heart rate, hypersensitivity reactions, nausea and vomiting, and hypoglycemia
