Signs/Symptoms: Adverse reactions from therapeutic doses include: sudden fall in blood pressure, bradycardia, transitory flushing, feeling of warmth, dyspnea, nausea, vomiting, lassitude, back pain, and anaphylaxis (severe respiratory distress, circulatory collapse, capillary leak, noncardiogenic pulmonary edema, acute pulmonary hypertension). Occupational exposure has not been fully investigated.

SECTION 4 : FIRST AID MEASURES
